As groups seek to advance their goals, whether for environmental justice, anticorruption, social justice or by refusing to cooperate with an authoritarian government, their message can be attacked by people who lose control of their emotions or by provocateurs who are sent to stir up chaos and turn the public away from the group's message.

Morning Training in Noncompliance:

As we build our movement to stop a dictator, we focus on how we strengthen our resistance, increase our numbers and effectively implement effective methods of noncooperation, in this 3-hour workshop.

Afternoon Training in Peacekeeping:

In this workshop, you will learn de-escalation techniques and effective methods that
