Two new video series bring FLIR OGI and civics to life



The first, **Everything's Fine**, highlights the use of Forward-Looking Infrared Optical Gas Imaging (FLIR OGI) in the field. The FLIR OGI camera is an infrared camera designed to detect leaks and releases of hydrocarbons, methane (CH₄), and other Volatile Organic Compound (VOC) emissions from multiple stages of the oil and gas supply chain, as well as other industrial facilities.

In the video series, we first see the scene as it would appear to the naked eye, followed by the FLIR OGI view. The second view shows a dramatic difference, with ominous plumes of emissions suddenly visible and - as the video tagline says - "once you see it, you can't unsee it."

EHP Releases New White Paper on the Health Risks of Gas Infrastructure

Pennsylvania residents face very real health risks posed by the ever-growing network of shale gas infrastructure - wells, compressor stations, processing plants, pipelines, truck traffic, etc. - and depend on Governor Shapiro and his administration to protect them from pollution and environmental damage. In his two years in office, Shapiro has yet to take real action, but still has a chance to do better for his constituents.

The Environmental Health Project's white paper, "Pennsylvania's Shale Gas Boom: What the Shapiro Administration Can Do to Better Protect Public Health," discusses the administration's shortcomings and the steps necessary to give Pennsylvanians critical public health protections.

EHP is gathering signatures on the letter accompanying the white paper, which will be sent to the governor after April 15.
